Free Extraction Well Water

A Valuable Resource for the Community

With the devastating drought showing no signs of stopping and recent State mandates for water conservation, the City of Fresno is looking at other sources of water that can replace potable water for non-potable uses. Although the City is in the process of implementing the adopted Recycled Water Master Plan and Recycled Water Ordinance, we cannot count on it as an available resource yet. In answering the public's need for other water sources for non-potable uses, the City has developed the "Extraction Well Water Fill Station" pilot program to provide free groundwater from the Fresno-Clovis Regional Wastewater Reclamation Facility to City of Fresno and Clovis customers. Extraction Well Water is water percolated from disposal ponds

where treated wastewater is placed. The soil provides additional filtration treatment resulting in good quality water that is safe for non-potable uses such as dust control, irrigation of landscapes and gardens, washing vehicles, and hard surfaces such as pathways and windows.

Residential customers may collect up to 300 gallons at a time while commercial customers may collect 300 gallons or more per load; residential and commercial customers may return as often as they like.All containers and tanks are inspected to ensure they are labeled with the words "Non Potable Water/Do Not Drink". The Wastewater Management Division has received 130 residential applications and 13 commercial applications over the last month.

WHAT'S YOUR NUMBER?

On April 1, 2015, Governor Jerry Brown imposed the first ever water restrictions in California, prompted by the Sierra snowpack at just 5% of the normal level. Executive Order B-29-15 required that the State Water Resources Control Board (SWRCB) impose restrictions to achieve a statewide 25% reduction in potable urban water use. Water use reductions are based on the amount of water used in 2013. The Order requires the Department of Water Resources to provide assistance for replacement of lawns with drought-tolerant landscaping. The Order included eight measures for saving water and eight requirements for increasing enforcement against wasting water. It also provides for investment in new technologies to manage water and for expedited government actions for drought relief.

On May 5, 2015, the SWRCB adopted an emergency regulation implementing the mandatory water reductions and assigning each of California's 411 urban water suppliers a tier water reduction percentage.

The regulation became effective on May 15, 2015. The nine tiers mandate water use reductions ranging from 4% to 36%. The SWRCB set reduction tiers based on historical reductions in water use per region. Below is a summary of the water conservation/reduction percentages along with recent residential per capita per day water use for water agencies in San Diego County.

On May 11, 2015, California Water Enivronmental Association (CWEA) teamed up with WateReuse California to present a one-day drought summit in Sacramento. The summit called, "Reinventing Urban Water, Portable Reuse", explored potable reuse and recycled water as new sources of water for the State as well as discussing the opportunities and regulatory hurdles they face.

Locally, water agencies are doing their part to educate the public on the State's emergency protocols. Agencies are offering outreach events to educate the public as well as rebate programs
