1. CDPHE-WQCD Items

- a. Regulation 84 Updates
 - i. Update on possible new uses effort/WQF workgroup (Damian) Denver Water submitted a rationale form for the Water Quality Forum Retreat. The proposal includes new uses (i.e. toilet flushing, decorative fountains, and edible crops) and a one water concept approach. Separate workgroups for each item could be established. Updates about the retreat will be provided at the September meeting.
 - ii. Discussion about UPC and agronomic rate requirements (Damian) CDPHE has changed the requirements for the UPC's as policy 21 states. Liz stated that the Division is now requiring agronomic rates for specific vegetation types for sites that have less than 90% turf to be consistent with policy 21. Damian noted that this type of data on several plant species, including native grass seed blends is not currently available. He has had several conversations with agronomists who have been unable to determine an exact agronomic rate. Liz and Maureen stated that they will be relying on the users to get this type of information from experts. The Division is planning a brownbag lunch event in August, this topic will be covered. Liz noted in the interim, general aggregate agronomic rates from an agronomist will be sufficient, or a requested variance in the NOA would be supported by the Division until data

was available. A pilot project could be warranted to quantify nitrogen uptakes for blends of native grasses, and other plant types.

- b. Graywater Non-Traditional Uses Update (Tara) No update. This item will be removed from future agendas, though the subcommittee will continue to monitor the status.
- c. Other Items –Colorado Springs completed a study under groundwater permitting rules for reclaimed water impoundments, Tara will share the outcome of the study at the September meeting.

2. Subcommittee Updates

- a. Scholarships (Tanja) The deadline for scholarship applications has been extended into July due to the small number of applications received. Tanja noted that a lower number of applications is expected due to the smaller number of students (10-15) directly involved with reuse related research in Colorado. Due to the length of academic programs and smaller numbers of students involved, Tanja suggested that 1 scholarship be offered instead of 2 in the future. The scholarship committee has been formed and it is expected to announce awards at the AWWA Conference in Loveland. Though, it was discussed that this event might not be appropriate as it is not a WRCO sponsored event. Dave will work with Abbey to identify other venues to support the awards, possibly during the treaters award ceremony that will be held in September in Castle Rock. Tanja also mentioned that she participated in a conference call with other large universities in the state to develop an internship program has yet to be determined.
- b. Website (Steve) new members: CDM Smith, Anadarko Anadarko is not currently on the website and will need to be added. Other updates include a new director for the City of Westminster as Bret Eastberg and a new director for Denver Water as Brenley McKenna.
- c. Education/Outreach/Public Relations:
 - i. Managing Salinity documents (Richard) No update
 - ii. Inter-organizational activities (Laura) On hold, focus efforts on WSRA grant
- d. Annual Awards (Abbey) Pushed back to September after normal meeting
- e. Industrial Reuse Committee (Abbey) No update
- f. Potable Reuse (Dave)
 - i. Potable Reuse Guidelines Update (John) The guidelines/regulatory framework developed by the National Water Research Institute (NWRI) and WRA are under technical peer review. The final document should be available at the end of the summer.
- g. WRCO WSRA Grant (John) –WRCO is gathering support in other basins, though with some pushback from the S. Platte basin, with the potential for less return flows. There will be a small group meeting in August. Other efforts include the original grant

application for framework with a decision tree and case studies and separate regulatory framework. Original plans has included a pilot plant project to be incorporated with education and outreach but these will now be standalone topics. WRCO has budgeted \$10,000 for this grant.

- h. Membership (Richard) No update
- i. Regulations/Local Codes (Tara) No update
- j. Reuse Roundtable (Damian) The timing for this event will be in January to coincide with the Colorado Water Congress winter session. The fermentation program at CSU is interested in brewing beer with recycled water for the event. Though, timing is not ideal for the January date to have the beer ready. Pathogen issues will also need to be addressed. Additionally, the CSU hospitality department has offered to provide the service for the food. The event will need a keynote speaker and Melissa Meeker will be in town and might be able to attend. Alternative speakers were identified as Rich Nagle, Bob Johnson, Mark Malone, or Dr. Jay Garland (EPA). It was noted that it would be beneficial if regulators from out of state could attend and provide insight for table topic conversations.

3. Other Business

- a. CWA/SDWA Nexus Workgroup (Damian) No update
- b. State Water Plan (Laura) The newest draft of the plan was posted on July 2nd. It is unknown if WRCO comments were incorporated into the latest draft.

5. WRCO Business

a. Summary DPR Workshop in May 2015 (Dave) - Over 60 people attended the workshop, including several visiting from out of state. Regulators from California were unavailable to attend but the Texas regulators (TCEQ) provided insight into the permitting processes involved with El Paso and Big Spring. There has been no requests to the CDPHE for this type of permitting. To date, no utilities in CO have identified plans to implement DPR. There was a division between the attendees that supported RO treatment and those who

did not. Other ideas that were suggested at the meeting included a implementing a pilot plant.

- b. Review 2015 Strategic Plan (Dave) see attached 2015 Strategic Plan Status of 2015 Action Items: WRSA grant is getting good traction, Industrial Oil/Gas item to go on back burner. It was stated that this group should have more of a presence at relevant conferences and events, increased engagement with users, gain a better understanding of long time users. Additionally, Brenley will be looking to form a group that will look at other education and outreach opportunities, if you are interested in participating, let Brenley know.
- c. Social Media Policy (John) To be discussed in at September meeting.
- d. Update on WRCO archives and Dropbox (Laura) This has been set up. This item will be removed from future agendas.
- e. New WRCO pins (Richard) No update

6. WRA/WRRF Items

- a. WateReuse Association (WRA) updates (Richard) Richard sent directors a letter regarding the association updates for membership goals, new members, financials, research, and overall updates to the association direction. There was a 90% renewal for the association and an 89% renewal rate for foundation members. A current research project '*Creating a Roadmap for Bioassay Implementation in Reuse Waters: A cross disciplinary workshop*' currently needs reviewers. If you are interested in reviewing this project, please contact Richard.
- b. Legislative/lobbying effort update (Damian) No update
- c. Research (John) -13 projects are currently being funded at a cost of ~\$6 million, of those 13 projects, 8 are funded through a DPR initiative. The research topics include regulatory, treatment, and monitoring. Other projects include developing curriculum and content for DPR operator training.

- a. AWWA Water Reuse Committee Updates (Tara) Will plan on quarterly calls. Water Resources Sustainability Division is offering the OASIS award for water resource sustainability. Nominations being accepted now. Group is discussing hosting or cohosting a Direct Potable Reuse Conference. See attached list of deadlines.
- b. WEF Water Reuse Committee Updates (Frank) There was a quarterly call in May, with a focus on internal coordination and technology design committees. The next meeting will be in August.
