1. January 25th Colorado Water Congress (Laura)

In 2016 there was a full day track on water reuse. Due to the success of the event we will again have a reuse track at the 2017 conference. Melissa Meeker will be participating thanks to Abby. There will be a panel discuss first that will focus on Colorado but also talking about what other states are doing. It will follow closely follow a webinar from last year talking about the Florida experience with DPR. The staff from Florida will be attending an event. The beer tasting will take place right after the panel. This beer is all brewed by home brewers. The beer tasting is a great way to get people interested and comfortable with beer brewed from recycled water. There will also be pints made to serve the beer in. Getting the beer to Colorado will be expensive, between \$1000-\$2000 for refrigerated beer. They will be shipping 100 16 oz of beer to allow for people to try 2 to 3 types of beer. Xylem and Tetra Tech will be committing money to help to pay for this (\$700 from Xylem and Tetra Tech). The budget includes: \$1022 for the pint glasses, shipping will be approximately \$1000 and \$50 for the hotel to receive the beer. Shipping could cost more if someone has to drive the beer from Florida to Colorado. The Governor will be speaking during lunch at the Water Congress. A request will be made to him to see if photos of the Governor with the pint glasses can be made.
