### Dave Smith, Ph.D, WateReuse Managing Director

Dave has over 30 years of experience in water recycling. He has managed planning, design and/or startup for more than \$1 billion in water recycling projects. He has an undergraduate degree from UC Davis in Aquatic Ecology, and a doctoral degree from the UC Berkeley College of Engineering. He started his career at the San Francisco Bay Regional Water Quality Control Board, then founded Merritt Smith Consulting in 1988. In addition to working on a broad range of water recycling issues and projects as a consultant, he also provides compliance and water quality services to drinking water utilities and addresses NPDES discharge and compliance issues for wastewater utilities. He became WateReuse California's first Managing Director in April 2009. In his role as Managing Director, he works on regulatory and legislative issues of concern to WateReuse members and manages the business affairs of the organization.

#### Rick Arber, PE, BCEE, Hatch Mott MacDonald

Rick has 39 years experience with water, wastewater, and water reuse projects. He has served as National Chairman for the AWWA Membrane Standards and Water Reuse Committees, and is active in WEF Water Reuse and WateReuse Association.

Rick holds a B.S. in Civil Engineering from Tri-State College in Angola, Indiana, an M.S. in Sanitary Engineering from Colorado State University, and is a registered Professional Engineer in several states including Colorado, California, and Arizona.

Rick has been involved with water reuse engineering since its inception in the United States. While with CH2M Hill, Rick was integrally involved in the design of the nation's first water reuse demonstration plant for the Denver Water Department in the 1970's. The project treated wastewater to potable quality water and included state-of-the-art treatment technology, as well as extensive analytical and health effects research, and required detailed aquatic chemistry knowledge and applications. The Consulting Engineers Council of Colorado Engineering Excellence Award was presented to this project.

Rick subsequently went on to head up his own consulting firm, Arber Associates, based in Lakewood Colorado. The firm specialized in water and wastewater treatment and water reuse. Arber Associates joined Hatch Mott MacDonald in 2011.
