#### 3. Reports

a. National Board Happenings (Brian)

Brian shared the draft 2015 Membership Growth Plan. Which includes goals and key observations such as the following:

- There are 403 members in 7 membership classes.
- California members generate the overwhelming majority of dues revenue (59%) with 103 agency/water supplier members.
- Texas has 16 agency/water providers and Arizona and Florida both have 14.

#### Goals include the following:

- 1. Increase membership through personal appeals.
- 2. Increase membership of Agencies & Water Suppliers in the Association.
- 3. Increase membership of Agencies & Water Suppliers in the Foundation.
- 4. Increase membership of Associate Members that are large and middle-sized companies in both the Association and the Foundation.
- 5. Increase membership of Associate Members that are small companies in the Association.
- 6. Increase membership of Industrial and Commercial Members in the Association and Foundation.
- 7. Increase membership of Affiliates in the Association.

Brian will be attending the WateReuse National Board meeting in Las Vegas on February 20<sup>th</sup>.

**ACTION ITEM:** How can we get more water agencies involved? Maria suggested we look at the ADEQ list of wastewater plants over 1 MGD at the board retreat and targets those.

### b. Committee Reports

### i. Membership (Robin Bain)

The membership committee has not had their quarterly call. We currently have 40 members (13 water suppliers, balance are affiliates or associates). Alan Plumber dropped state membership, Aqua Aerobics selected AZ as primary state.

ACTION ITEM: NAU is not a member, Channah will approach her contacts to recruit them.

There was some discussion about replacing our chapter Banner which we will need before AZ Water conference to help promote our conference this summer. Two banners (section and national) are needed, but we may not be able to get approval for the messaging for the national banner in time.

**ACTION ITEM:** Robin will work with Maria to have it designed by Stantec's marketing group. We may be able to use existing equipment and just replace the banner.

# ii. Education (Channah Rock):

Advisory Panel of Emerging Contaminants (APEC) final report is due soon. Dan Quintanar (Tucson Water) is the lead for the Education and Outreach committee and is working to finalize the comprehensive report to be presented to ADEQ and ADWR later this year.

AZ Water Research Workshop held at SRP Pera club on 01/14/15. Several members were involved however attendance was poor. Those in attendance included myself and Guy Carpenter as well as consultants and cities involved in WateReuse AZ. AZ Water Research workshop was poorly attended due to late release of agenda and late advertising. She recommends WateReuse AZ chapter gets involved for next year. It's a good opportunity to recruit members. AMWA committee meeting was in conflict for some to attend. We need to check schedules and communicate better for next year.

- iii. Technical Committee (Bob Hollander/Gary Gin):

Bob not in attendance. Gary Gin, City of Phoenix reported for committee. A white paper is being produced through a graduate student who is coordinating meetings with the County, ADWR, ADEQ, and experts in the field like Guy Carpenter. The concept was created during the Govenor's Blue Ribbon panel from 2010. Paper will focus on "Where have we progressed?" Will be final mid-2015.

# c. Financial Report (Maria Brady)

The only new item from the last report was the conference call from last quarter's board meeting. We are under budget on most categories. The 2015 budget will be discussed at the board retreat. We need to make sure we have Lisa Culbert's contract in the 2015 budget.

The 2015 scholarship program will be released in March to all the Arizona universities. The advertisement will go through June. In July the applications are considered by a volunteer group. Two \$2500 scholarships will be awarded.
