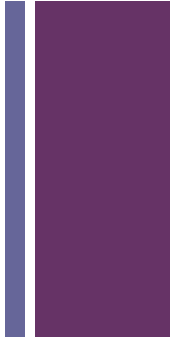


Officer Elections

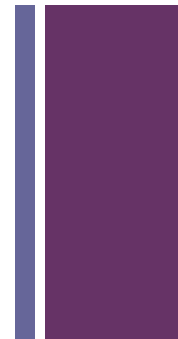
