WRCO DPR Project Phase I – John Rehring

- We can do a brown bag on the WRCO DPR project; it might be easiest to do that in conjunction with the January WRCO meeting when everyone will be together again (vs. trying to pick a separate date when everyone could be available)
- DPR project update regulatory development, outreach, and technical tools
 - o Regulatory writing up the implementation plan for regulatory development
 - Health-based standards
 - Administrative elements (internal CDPHE element) working with Division staff about how to develop/cover those
 - Both have regulation, policy, and guidance elements
 - CWCB grant to support development of health-based standards for DPR
 - We've raised \$35k; asking for 65k
 - Outreach subgroup; identified key audiences; drafting a DPR fact sheet to host discussions 1 on 1 with key stakeholders; then plan next steps; DPR demonstration pilot
 - Technical integrated toolbox for potable reuse modifying the toolbox to include some processes that are not in it; screens treatment trains for pathogen removal and other constituents like NDMA; will do some case studies with utilities identified in the last workshop
- Carollo will be doing a DPR demonstration in conjunction with the WRCO DPR project's outreach task in 1Q2018, as noted at the last meeting.
 - Coalition of in-kind contributions equipment manufacturers, engineering support, and host facility identified (Denver Water)
 - o It'll be a relatively short term demonstration, so I think it still makes sense to consider a possible longer-term demonstration (perhaps mobile / similar in concept to the AZ model) where we can get more direct public access and more time to work with treatment and monitoring technologies. The near-term demonstration could be a vehicle to help garner legislative (et al) funding support for the longer-term demonstration.
 - o Operational for a few months
 - o Might be able to generate support for funding a mobile treatment unit
- Laura and John are now working on supporting the CWCB grant app through the CWCB/BRT process. If successful, that addresses part of the need (developing health based standards), but we are still working with WQCD to identify the anticipated WQCD staff workload for reg development and administration, and how to cover it.

- b. Reg 84 New Uses (Damian)
 - DW and other stakeholders in the reuse community had interest in gaining approval for new
 uses for some time. Division had resource constraints that we were able to address in
 getting funds allocated from CWCB and Water and Power Authority for 1 FTE (Brandi
 Honeycutt). Originally proposed toilet flushing, livestock washdown, edible crops for
 community gardens, commercial edible crops (including marijuana), and impoundments.
 Have pared the list down to toilet flushing and marijuana.
 - Other entities are pondering taking on the edible crops in community gardens (Denver Urban Gardens and Dave Takeda and his client).
 - Informal stakeholder process over the past year has preceded the formal rulemaking process leading up to the formal hearing August 6, 2018.
- Water Environment & Reuse Foundation and Water Research Foundation 1:50 1:55
 - Update (Brenley)
 - As of January 1, 2018, becoming the Water Research Foundation (WRF); will have 1200 members, 2300 research, \$700 million value of research portfolio (past). Subscribers wanted this merger to happen.
 - 2018 the historical WE&RF and WRF research portfolios will be maintained and there will be a proposal for the Board of Directors to vote on for new programs in 2019.

Water Reuse Legislation

2:00 - 2:30

 Chris Piper (Denver Water Government Relations Manager) and Brandi Honeycutt (WQCD) – update on Colorado General Assembly Interim Committee reuse bills and actions

DW has been talking with legislature about how to implement the Colorado Water Plan, which outlines goals including reuse.

Legislature meets from January through May in the regular session. Rest of the year is off session in which interim committees meet. The Water Resources Review Committee meets 5-6 times in the summer and fall to invite people to give updates and talk about water topics and to decide whether the legislature needs to change policy or pass laws regarding those topics.

In September the WRRC had a 2-day hearing in which they invited several entities to come talk about reclaimed water, reuse water, and other topics. CDPHE, Denver Water, and others were present. There were bills for toilet flushing, edible crop cultivation, marijuana cultivation, and hemp cultivation. Denver Water was asked to participate in the drafting of those bills. DW agreed and helped their legislative drafting team work on language that would meet the requests of the legislature.

On October 3rd, the committee reviewed 10 draft bills and combined toilet flushing and irrigation of edible crops into one bill (4b) and left marijuana and hemp in different bills.

On October 31st, the committee met to take final action on those bills. Bill 4b was defeated on a 6 to 4 vote. It takes 7 votes to recommend legislation. There were concerns around irrigation of edible crops – questions about salinity. There didn't seem to be concerned about toilet flushing.

2 remaining bills (marijuana and hemp) will be introduced into the legislature as actual bills in January and go through the regular process, including at least 2 opportunities for the public to testify; opportunity to amend the legislation.

There's an opportunity right now to propose bills through individual legislators, who are allowed to introduce 5 bills, but that # can be increased with the agreement of the chamber leadership (speaker and minority leader). That is typically granted.

Brandi Honeycutt

Two main issues the Division had with the bills. Doesn't include an iterative stakeholder process. Also doesn't allow evolution of reuse requirements as scientific information emerges to protect public health. The Division has some specific questions about the 4 uses.

a. Graywater Non-Traditional Uses (Tara)

At the end of 2015, the Water Quality Control Commission passed Regulation 86 that governs the use of graywater for toilet flushing and subsurface landscape irrigation. The program is administered at the local level. There must be the development of a local ordinance to allow it to be used in a region. To this point, Denver is the only entity that has developed an ordinance.

Kyle – went to a stakeholder meeting a year ago to allow flexibility for research entities.

b. WRA Industrial Reuse Committee (Frank)

Interest in coordinating with the WEF industrial waste committee.

c. Statewide Water Supply Initiative (Laura)

The state is rotating – we do SWSI and the Basin Implementation Plans – they kick off after each other. The Metro Basin and South Platte Basin have a plan that touches reuse. The SWSI now incorporates BIPs to set up for their implementation. Laura has been reaching out to CWCB to make sure reuse is included. There's interest in developing models for the basins, including water reuse (existing and planned).

d. Water Environment Federation (WEF) / Rocky Mountain Water Environment Association (RMWEA) (Damian)

No update.

e. WEF Water Reuse Committee Update (Frank)

The annual committee meeting was held at WEFTEC October 1. The Water Reuse Roadmap is officially rolled out. They've updated the WEF Water Reuse Policy Statement. Abstracts are due December 3 for WEFTEC. Workshops due next Tuesday – 3 reuse workshops are being submitted. Two reuse publications submitted – industrial reuse (Al Goodman), potable reuse (Gary Hunter is chair). March 8th webcast planned. Specialty conference on reuse and disinfection planned for July in Oregon.
