- 0. Eat and Visit
- 1. Welcome and Introductions: Introductions around the table
- 2. Approval of the Agenda: Item 6- Award Scholarships moved forward to after item 3. Approved.
- 3. Review and Approval of Meeting Minutes of October 11, 2017: No comments, Approved
- 6. Award Scholarships: There were many great applications for scholarships this year, so six awards were presented instead of the originally planned four. Scholarships for \$1,000 were granted to Graduate Students: Fernanda Bacaro, Alisson Luiz Boeing, John Gonzales, and Harshad Oswal, as well as Undergraduate Students: Yesika Otano Alonso and Hannah Woods.
 - 4. Finance / Treasurer's Report: Balance is \$124k after the scholarships.
 - 5. President's / Past President's Report:
 - a. Dan noted that the WateReuse Association activities include:
 - i. working to preserve the tax exempt status of advance refunding and private activity bonds.
 - ii. pushing for increased budget funding for Title XVI, WIFIA, and state revolving funds.
 - iii. helped produce and promote Priorities for the Nation's Water Infrastructure http://www2.apwa.net/Documents/Advocacy/Water-Policy-Booklet-FINAL.pdf
 - iv. realizing increased membership, up 15% over last year, to a current total membership of 484.
 - v. is now producing a weekly newsletter called WateReuse Review, for which we are encouraged to provide information for inclusion.
 - b. Finances for the WateReuse Association
 - i. The Association had a net loss of \$141k last year due to staffing changes and a last minute conference cancellation.
 - ii. Dues revenues were strong at \$1.22M (\$412k of which will be returned to the State Sections), exceeding expectations by 9%.
 - iii. Association reserves remain strong at \$899k.
 - iv. The Board approved a new budget for \$1.94M. Expenses were budgeted to match expected revenues, so a "balanced" budget.
 - c. Dan summarized the calendar of upcoming events. CA Symposium March 25-27, 2018, Water Research Foundation Conference May 7-8, 2018, and the WateReuse Symposium September 9-12, 2018 (Austin, TX).

7. Committees

- a. Public Education and Outreach:
 - i. Have a budget of \$500 to spend on give-a-way items, doing count on current inventory of items.
 - ii. Will consider hosting a booth at the Spring Wash Green Up
 - iii. Presented a flyer designed by the committee for the Wash Green Up and other events.

- iv. Proposed to sponsor the NWRA conference at the Silver Level (\$1,000). Motion made, seconded, and approved.
- b. Regulatory and Policy: Cory noted the committee is tracking industry regulations:
 - Colorado has a goal to have Direct Potable Reuse regulations within two years.
 They are aiming for flexibility to allow for technology advancement by leaving details to policy, but outreach is a requirement.
 - ii. California: Expert panel made recommendations, which are being researched prior to regulations being drafted.
 - iii. Arizona: Committees formed to recommend reclaimed water regulations to AZDEQ. Considering DPR usage and treatment requirements for A and A+ reclaimed water.
