Possible Legislation for 2019

Remove IPR-DPR references in code: WateReuse CA

Title 17 and 22 changes for non-potable reuse: WateReuse CA

Proposition 3 (If it passes) contains \$400 million for grants and loans for recycled water/potable reuse projects. Funding would go to the Water Board but there may bill implementing legislation or attempts at earmarks.

Require recycled water "purple pipes" to be subject to leak loss detection rules (SB 555): Possibly environmental community

Require some prohibition on ocean/bay discharges. Possibly NRDC reintroduction of this kind of bill from 2016.

AB 2072 (Quirk- CECs) Develop a CEC program at the Water Board for recycled water and all drinking water. Failed to pass last year. Author may want to pursue.

WateReuse: Federal Recycled Water Update

• Title XVI-WIIN -- \$225 Million Request

WateReuse is also seeking reauthorization and funding increase for Title XVI-WIIN, a competitive grant program within the Bureau of Reclamation's Title XVI water recycling program that Congress authorized in the 2016 Water Infrastructure Improvements for the Nation (WIIN) Act. There may be an opportunity to reauthorize the Title XVI-WIIN program as part of the reauthorization effort for the Water Resources Development Act (WRDA) Congress is currently debating. WR is currently requesting \$225 million over five years for this program.
