The Arizona Department of Environmental Quality (ADEQ) is in the early stages of planning to launch a rule modification process to provide a clear permitting process and regulatory standards for direct potable reuse (DPR) of reclaimed water.

ADEQ plans to revise its DPR rules to: address minimum performance requirements, source control, design elements to prevent contamination of the water supply, operator qualifications and training, technical, managerial, and financial requirements, uniform terminology, and other issues.
